## POLICY ON REVISIONS FOR MSC THESIS DEFENSE:

- Present Form: No changes necessary
- Minor Corrections: Involves typographical errors, errors in punctuation or problems in style. These alterations must be completed within one month (at least one week prior to the deadline for submitting a degree recommendation to the School of Graduate Studies). Changes are checked by the Supervisor(s) and the committee will inform the Graduate Chair/Coordinator in writing.
- Minor Modifications: Involves more than changes in style and less than major changes in the thesis. A typical example of a minor modification is clarification concerning textual material or the qualification of research findings or conclusions. Changes are checked by the Supervisor(s) and must be capable of completion within three months, preferably as soon as possible. The Supervisor will inform the Graduate Coordinator in writing.
- Major Modifications: Entails substantial revisions in one or more of the conceptual rationale, design, documentation and conclusions of the research. This decision would result in an adjournment with a reconvened examination to be held within the year by the Examination Committee. When changes have been made and are checked, the Supervisor will then write a brief letter to the RSI Director indicating that these changes have been made before the thesis will be accepted by the Department.
